I apologize for the delay in a reply to your letter sent to Seton Board Members in December. After receiving a copy of your letter, I have spent some time talking to our Medical Staff directly involved with ECT, and have reviewed and attempted to review the references mentioned in your letter.

As Medical Director of Seton Shoal Creek Hospital, teaching faculty member of the Austin Medical Education Program, Psychiatry Section, and a clinical specialist in Bipolar Disorder, my knowledge and experience with ECT is limited to my patients who have had ECT, my psychiatry colleagues directly involved in ECT, and professional psychiatry resources. I was disappointed your letter was so politically focused with few professional references. I was hoping to educate myself further with some views I possibly have not seen. I did recently receive a copied letter from Dr. Dolan, well referenced, which I welcomed.

I affirm and reassure you of the practiced reality to Seton's Mission Statement. All of our hospitals and outpatient facilities, including our psychiatry facility, Seton Shoal Creek, are daily committed to Seton's mission and responsible to safety and quality care for our patients.
